2024 Net Surplus Compensation - Cash Out Form

Follow the steps below to receive your net surplus compensation by check. As described in the CleanPowerSF NEM Tariff¹, our Net Energy Metering customers who produce more electricity than they use over the course of a year will receive compensation for that excess electricity at the end of the annual true-up period. By default, your compensation is issued as a credit on your electricity bill. You can follow the steps below to receive it as a check instead.

To Receive Your Net Surplus Compensation by Check:

1. **Complete and return this Cash Out Form to CleanPowerSF.** Please send completed forms to CleanPowerSF via email (cleanpowersfforms@sflower.org) or mail to:

Please note: Forms must be received within 60 days of the first bill following the end of the Annual True Up period or by August 20, 2024, or within 90 days of when your CleanPowerSF account has closed.

2. **CleanPowerSF may contact you via email to sign and submit a W-9.** After we receive your completed Cash Out Form, we will contact you via email. If the Controller's Office does not already have your W-9 form, they will send a secure email request to submit an IRS Form W-9², which must be wet signed or with a digital signature (DocuSign/Adobe Acrobat Sign). If you prefer to mail your W-9, send it to:

Please note: For your data security, do not submit the W-9 form to CleanPowerSF.

3. **Your cash out check will be mailed to the address listed on your W-9.** After you sign and submit your W-9, you can expect your mailed check in 4-6 weeks.
